2017 WATER SPORTS TRIP APPLICATION

You are invited to join WWSC for a weekend of boating and water skiing on the California Delta in Stockton. Unlike California's lakes, the delta remains at (or above) sea level, undoubtedly a bit less brackish than in previous years. Tournament class water ski boats and friendly drivers provide for a FUN experience for experienced water skiers and aqua planers. Boating Hours for this water sports trip are typically: 8:00 AM to no later than 30 minutes prior to sundown on Friday and Saturday, and 8:00 AM to at least 1:30 PM on Sunday. This year due to the huge snow pack which feeds this area, the San Joaquin County office of Emergency Services has imposed some restrictions 2 hours before and 2 hours after high tides. If implemented we will need to adjust our boating hours to maximize use of the Delta during daylight hours.

We will be staying at Turner Cut Resort in Stockton. Tent sites or RV sites (with water/electric hookups) are provided. Tasty breakfasts and gourmet dinners are also included in the price of the trip. The pre-dinner (post Boating Hours) cocktail party is the place to tell your stories of the days accomplishments. Non-Alcoholic alternatives are available. After dinner, bring your chair and gather round for more socializing or head back to your tents for a relaxing evening.

Participation for each trip is limited by the availability of boats, so there is rarely a wait. Don't be left out of the best summer events that WWSC offers. **Sign up early to guarantee your space.**

NOTE: While WWSC cannot arrange carpools, we can put you in touch with other people that are looking for riders or rides. If you want to arrange a carpool, please call the number below for more information.

WAIVER AND GENERAL RELEASE OF LIABILITY AND INDEMNITY AGREEMENT
READ BEFORE SIGNING
(EACH PARTICIPANT NEEDS TO COMPLETE A SEPARATE WAIVER AND RELEASE OF LIABILITY)

In consideration of being allowed to participate in any way in the WESTWOOD SKI CLUB, INC.'s ("WWSC") programs, water sports programs, related events and activities, I, _____, the Undersigned, acknowledge, appreciate and agree that:

1. The risk of injury from the many of the activities is significant, including the potential for permanent paralysis and death, and while particular skills, rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION;** and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS WWSC**, or any of its officers, officials, directors, employees, members, representatives, agents and volunteers, volunteer boat drivers or boat owners, other participants, contractors, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (the "RELEASEES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.

I ACKNOWLEDGE THAT BOATING, WATER SPORTS, AND PARTICIPATION IN THE TRIP ARE POTENTIALLY DANGEROUS ACTIVITIES, AND I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE RISKS AND DANGERS INVOLVED AND I HEREBY ASSUME ANY AND ALL RISKS, KNOWN OR UNKNOWN, OF PARTICIPATION, INCLUDING INJURY, DEATH OR DAMAGE TO PROPERTY.

AS LAWFUL CONSIDERATION for being permitted by WWSC and its volunteer boat drivers and boat owners to participate in this activity and use its/their equipment, I hereby agree that I, my heirs, spouse, next of kin, distributees, guardians, legal representatives and assigns will not make a claim against, sue, attach the property of, or prosecute the RELEASEES, for injury, death or damage resulting from my participating in the referenced activities, whether by reason of the negligence of RELEASEES or otherwise, except that I retain the right to recover damages to the extent of any amount otherwise payable under any policy of insurance held by the WWSC and/or the owner of any boat or other vehicle involved in an incident in which I suffer injury or death. In addition, subject to the right retained by me in the last phrase of the preceding sentence, I hereby release, discharge, indemnify, covenant not to sue and hold harmless the RELEASEES from all actions, claims or demands I, my heirs, spouse, next of kin, distributees, guardians, legal representatives, or assign now have or may hereafter have for injury, death or damage resulting from my participation in the referenced activities. I acknowledge that I have been advised to wear a coast guard approved life vest while on or near the water and suitable clothing at all times. California Harbor & Navigations Code §655 states, in part: "No person shall operate any vessel or manipulate water skis, an aquaplane, or a similar device while under the influence of an alcoholic beverage, any drug, or the combined influence of an alcoholic beverage and any drug." I represent and warrant that I will not consume alcohol prior to my getting onto a boat or prior to, or while participating in, WWSC water sports. I further warrant that if I consume any alcohol during the Boating Hours specified that I will not get onto a boat. By my signature below, I acknowledge that I will inspect any equipment provided to me and will not use it unless I find it free of apparent defect, damage or items needing repair. I represent and warrant that I am experienced in water sports and I will not use any equipment provided unless I am familiar with it and I know how to operate it.

I AM AWARE THAT THERE WILL BE NO LIFEGUARDS OR OTHER SUPERVISION PROVIDED AT ANY TIME DURING THE TRIP. I EXPRESSLY ACKNOWLEDGE AND AGREE THAT ALL RESPONSIBILITY FOR THE CARE AND SUPERVISION OF ANY MINOR CHILDREN ACCOMPANYING ME ON THE TRIP SHALL BE MY RESPONSIBILITY ALONE, AND WWSC EXPRESSLY DISCLAIMS RESPONSIBILITY OR LIABILITY FOR THE CARE AND SAFETY OF SUCH MINOR CHILDREN.

I expressly agree that the foregoing General Release of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. I have read and understand the above statements, and I am signing this form, granting this release and participating in the trip voluntarily.

I HAVE CAREFULLY READ THIS WAIVER, GENERAL RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
